Stanley Lewis, winner of a Guggenheim Fellowship and the National Academy of Design's Altman Prize and Ranger Fund Purchase Award, was recently honored with retrospective exhibitions at the Visual Arts Center, Summit, NJ, and the American University Museum, Washington, DC. His many exhibitions include group shows at the American Academy of Arts & Letters and Salander-O'Reilly Galleries. He currently exhibits at Lohin Geduld Gallery, New York City.

Located in the heart of the Chelsea art district, Bowery Gallery is pleased to host its 20th Juried Competition. Over its 40-year history, Bowery Gallery exhibitions have been reviewed in *The New York Times*, *The New York Sun*, *The New Republic* and many other publications. The reception for the 2011 Juried Competition will be 5-8pm Thursday, August 4.

ELIGIBILITY Eligible two dimensional media include painting, drawing, printmaking and mixed media. Sculpture is not eligible. Work cannot exceed 36" in height/width, including frame or other presentation. Work will not be accepted from non-US addresses.

PRESENTATION All works must be suitably framed and ready for hanging. Drawings, prints, watercolors, and pastels must be under Plexiglass. (Glass is permissible for hand-delivered work.)

SALES All works in show are for sale unless the artist informs the gallery to the contrary. All proceeds from sales will go to the artist.

FEES A \$30.00 entry fee allows each artist to submit 1-3 images. A \$5.00 fee is required for each additional image. A maximum of 6 images may be submitted. Please make checks or money orders payable to Bowery Gallery. Entry fees are nonrefundable. There are no handling fees for accepted work, but artists are responsible for all shipping costs.

SELECTION All work will be juried from JPGs sent on CDs. No DVDs please. Do not send TIFs or PPTs. Images should not exceed 1000 pixels in height or width. Unreadable CDs and incomplete applications will not be considered. The gallery reserves the right to reject work not accurately represented by JPG entries. Please write your name on CD. CDs will not be returned. Please include SASE for notification.

JPG FILE NAMES Image file names should consist of: last name, image number, title, dimensions, and medium. Please use letters, numbers and underscores only; for inches, use "in" instead of quotation marks, i.e.:

Smith_2_ThisAndThat_16x20in_InkPaper.jpg

RECEIVING All accepted work that is shipped must arrive by Saturday July 30. Hand-delivered work must arrive at the gallery on Thursday July 28, Friday July 29, or Saturday July 30 between 11am and 6pm. Work arriving late will not be hung; substitutions will not be accepted. All work must remain for the exhibition's duration. Use correct packing procedures; send work only in a reusable container! Artists are responsible for shipping costs to and from the gallery and must arrange for any insurance in transit. Return shipping must be pre-paid through UPS or FedEx. Additional shipping information will be sent for accepted entries.

REMOVAL All work must be picked up from the gallery on Sunday August 21 or Monday August 22 between 11am and 6pm. Works not removed from the gallery on these dates will be placed in storage and released at gallery's convenience.

LIABILITY All artwork will be handled by experienced personnel and the utmost care will be taken to ensure the safety of the work. Bowery Gallery, however, will not be responsible for any loss or damage to the work while in the gallery or during shipping to or from the gallery. Insurance is the responsibility of the artist.

DEADLINE Applications must be postmarked by April 15, 2011. The gallery will make every effort to notify applicants of acceptance by June 1, 2011.
