Lance Esplund, Juror

Lance Esplund is the U.S. art critic for Muse, the arts and leisure section of Bloomberg News. Previously, he was an art critic and columnist for The Wall Street Journal and senior art critic for CityArts Magazine. From 2004 to 2008, he was chief art critic for The New York Sun. He has contributed to Art & Antiques, Art in America, Harper's, The New Criterion, The New Republic, The Threepenny Review, The Weekly Standard, and The Yale Review, among other publications, and he served on the editorial board and as New York correspondent for Modern Painters Magazine.

ELIGIBILITY Eligible two dimensional media include painting, drawing, printmaking and mixed media. Sculpture, photography and digital art are not eligible. Work in excess of 36" in height or width, including frame, will not be accepted. Work cannot be accepted from non-U.S. addresses.

PRESENTATION All works must be suitably framed and ready for hanging. Drawings, prints, watercolors, and pastels must be under Plexiglass. (Glass is permissible for hand-delivered work.)

SALES All work will be for sale unless the artist informs the gallery to the contrary. All proceeds will go to the artist.

FEES A \$35.00 entry fee allows each artist to submit 1-3 images. A \$5.00 fee is required for each additional image. A maximum of 6 images may be submitted. All entry fees are to be paid to Bowery Gallery through a Paypal link in the entry form. Entry fees are nonrefundable. There are no handling fees for accepted work, but artists are responsible for all shipping costs.

SUBMISSION Work will be juried from images submitted only through Bowery Gallery's online submission form at www.bowerygallery.org/JuriedShow.html. All images must be JPGs (no TIFFs, PNGs, or PPTs), minimum width/height 500px, maximum width/height 1000px. Embedded sRGB color profile recommended. Image file names must include name of applicant. The gallery reserves the right to reject work inaccurately represented by entries.

RECEIVING All accepted work that is shipped must arrive by Saturday July 28. Hand-delivered work must arrive at the gallery on Thursday July 26, Friday July 27, or Saturday July 28 between 11am and 6pm. Work arriving late will not be hung; substitutions will not be accepted. All work must remain for the exhibition's duration. Use correct packing procedures; send work only in a reusable container! Artists are responsible for shipping costs to and from the gallery and must arrange for any insurance in transit. Return shipping must be pre-paid through UPS or FedEx. Additional shipping information will be sent for accepted entries.

REMOVAL All work must be picked up from the gallery on Sunday August 19 or Monday August 20 between 11am and 6pm. Works not removed from the gallery on these dates will be placed in storage and released at gallery's convenience.

LIABILITY All artwork will be handled by experienced personnel and the utmost care will be taken to ensure the safety of the work. Bowery Gallery, however, will not be responsible for any loss or damage to the work while in the gallery or during shipping to or from the gallery. Insurance is the responsibility of the artist.

DEADLINE Applications must be submitted by midnight on April 15, 2012. The gallery will make every effort to notify applicants of acceptance by June 1, 2012..
