JULY 28 - AUGUST 15, 2009 PAUL RESIKA, JUROR

Bowery Gallery, founded in 1969 and relocated to New York City's Chelsea district, is sponsoring its' 17th annual juried competition. This year's juror, Paul Resika, is an internationally known painter. His works are included in many private and public collections including the Metropolitan Museum of Art, New York, and the National Museum of American Art in Washington, D.C. He has exhibited extensively both in the U.S. and abroad, including shows at Salander O'Reilly in New York, and Hackett-Freedman in San Francisco. He currently lives in New York City and Provincetown, MA. The juried exhibition will be held July 28-Aug 15 2009 at the Bowery Gallery. The opening will be held on Thursday July 30, 5-8PM.

**ELIGIBILITY** Two dimensional media including: painting, drawing, printmaking and mixed media. Sculpture is not eligible. Works must be no larger than 36" in any dimension, including frame or other presentation. No work will be accepted from non-US addresses.

**PRESENTATION** All works must be suitably framed and ready for hanging. Drawings, prints, watercolors, and pastels must be framed under plexiglass. (Glass is permissible for work to be hand-delivered to and from gallery)

**SELECTION** All work will be juried from jpeg images only, sent on CD—not DVDs. Please do not send tiffs or ppt's. Each image should be titled in the following format: First Image: Last Name\_\_1\_\_title\_\_size\_\_medium.jpg  
Second Image: Last Name\_\_2\_\_title\_\_size\_\_medium.jpg, etc. Size of works should be labeled as inches (in) not as quotation marks. Image files should not exceed 1000 pixels in either dimension. Please write your name on the CD. CD's will not be returned. Please include an SASE for notification. Incomplete applications or unreadable CD's will not be considered. The Bowery Gallery reserves the right to reject work not accurately represented by jpeg entries.

**DEADLINE** All applications should be postmarked by April 15, 2009. The gallery will make every effort to notify applicants of acceptance by June 1, 2009.

**FEES** A \$30.00 entry fee allows each artist to submit 1-3 images. A \$5.00 fee is required for each additional image submitted. A maximum of 6 images may be submitted for the competition. Please make checks or money orders payable to Bowery Gallery. Entry fees are nonrefundable. There are no handling fees for accepted work. Artists however, must pay shipping costs.

**SALES** All works in the show are for sale unless the artist informs the gallery to the contrary. All proceeds from sales will go to the artist.

**RECEIVING** All accepted work that is shipped must be received no later than Saturday July 25. Hand-delivered work must be brought to the gallery on either Thursday July 23, Friday July 24 or Saturday July 25, between 11AM and 6PM. Work that is received late will not be hung in the exhibition. All accepted works must remain for the duration of the exhibition. Substitutions will not be accepted. Artists are responsible for all shipping costs to and from the gallery. The artist must arrange for insurance in transit. **Please use correct packing procedures; send work in reusable containers only!** Return shipping must be **pre-paid** through UPS only. Additional shipping info will be sent for accepted entries.

**REMOVAL** All works must be picked up from the gallery on Sunday and Monday August 17 and 18, between 11 am and 6 pm. Works not removed from the gallery on the correct dates will be held in storage and released at the convenience of the gallery.

**LIABILITY** All work will be handled by experienced personnel and the utmost care taken to guarantee the safety of the work. However, the Bowery Gallery will not be responsible for any loss or damage to the work while in the gallery or during shipping to or from the gallery. Insurance is the responsibility of the artist.
